## NONCOMPLIANCE SUMMARY

The offender has failed to comply with the following condition of supervision:

Violation Nature of Noncompliance

Statutory Condition: "Defendant shall not commit another federal, state, or local crime."

On September 15, 2010, Jerome M. Koosman was stopped by a St. Croix County, Wisconsin, Sheriff's deputy and charged with operating a motor vehicle while intoxicated (1<sup>st</sup>) and operating with PAC >=.08 (1st).

Adjustment to Supervision: On June 30, 2010, Jerome M. Koosman began his term of supervised release. He is a retired professional baseball player living on his pensions. On September 16, 2010, Mr. Koosman reported his police contact in the above matter to the probation office. He admitted he had been drinking the night before at a golf tournament. He did not remember much of the traffic stop and was surprised to learn that his BAC was .22. Mr. Koosman was reprimanded for his poor decision making. He maintains that it was an isolated incident and that he will fully comply with the sanctions imposed by the State.

On October 19, 2010, Mr. Koosman completed a substance abuse assessment and driver's safety plan evaluation in Polk County, Wisconsin. No treatment was required; however, it was recommended that he complete a victim impact panel session and a 20-hour driver's safety plan course. Mr. Koosman has completed the victim impact panel session and is enrolled in the next driver's safety plan course in January 2011.

Mr. Koosman has been charged in St. Croix County, Wisconsin, Circuit Court (Case Nos. 2010TR006452 and 2010TR006453). His next court date is scheduled for November 9, 2010.
